GENERAL INFORMATION

Course Description

The Pediatric Education Conference is presented by members of the faculty of the Department of Pediatrics at the University of Iowa Carver College of Medicine as well as by selected guest faculty. The program is designed to provide pediatricians, family physicians, nurses, and other child health care providers with an overview of recent developments in areas of current interest, concern and controversy. The 2011 conference will focus on Child and Adolescent Mental Health issues relevant for the general pediatrician, family practitioner and other healthcare professionals who work with children and adolescents.

Objectives

Upon completion of the course, participants should be able to:

1. Act as a first resource for children and families with mental health concerns.
2. Discuss the scope and impact of children's mental health problems.
3. Use standardized tools for mental health, developmental and autism screening.
4. Screen, evaluate, and treat adolescents for mental health needs.
5. Listen firsthand about the challenges faced by families of children with mental health problems.
6. Evaluate and initiate treatment for urgent mental health problems in children and adolescents, including psychopharmacology.
7. Screen and address parental depression.
8. Recognize the consequences of parental mental health on young children's development and well-being.
9. Discuss mental health initiatives in Iowa and the U.S.
10. List mental health resources in Iowa.

Registration Fees

The registration fee for the conference is \$170. The fee includes breaks, continental breakfast, luncheon, syllabus, parking and the processing of continuing education credits. Nurses and other health professionals may register for \$70. Residents and fellows from other institutions may register for \$25 upon presentation of a letter of introduction from their chief of staff. Full time Carver College of Medicine faculty, non-salaried clinical faculty, residents, fellows and medical students attend the conference for free but must register and pay \$10 if they wish to receive lunch and conference materials.

REFUNDS

While registration is open until the start of the meeting, we encourage early registration to enable us to provide the best possible service to participants. A conference refund is available minus a \$25 cancellation fee, up to one week prior to the conference. No refunds will be allowed after Friday, September 16, 2011.
